4. FIRST AID MEASURES

First Aid Procedures:

Inhalation: Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. WARNING! 5. FIREFIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions and
