### 4. FIRST AID MEASURES

#### First Aid Procedures:

**Inhalation:** Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. Get medical attention if symptoms occur.

## 6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions and Protective Equipment:** Isolate hazard area and keep unnecessary and unprotected personnel away from the area of the leak or spill. Keep upwind. Wear appropriate personal protective equipment (see Section 8). Avoid contact with eyes, skin, and clothing.

**Emergency Procedures:** In case of chemical emergency, or if unsure how to address an accidental release, consult a professional (see Section 1).

**Methods for Containment:** Prevent entry into waterways, sewer, basements, or confined areas. Avoid generation of product as dust. Product should not be released to the environment. Contain and recover crystal when possible.

**Methods for Cleanup:** Sweep or collect spill with an inert material (e.g. vermiculite, dry sand, earth, cloth, or fleece) and place in a non-combustible container for reclamation or disposal. Do not flush to sewer. Clean contaminated surface thoroughly. Residues from spills can be diluted with water. Never return spills in original containers for reuse. ## 7. HANDLING AND STORAGE

**Handling:** Wear personal protective equipment (see Section 8). Use only in well-ventilated areas. Provide sufficient air exchange and/or exhaust in work rooms. Avoid contact with skin, eyes, and clothing. Avoid generation of dust. Do not breathe product dust. Limit exposure to moisture. Do not ingest. When using, do not eat, drink, or smoke.
